4. First-Aid Measures

General advice:

First aid providers should wear personal protective equipment to prevent exposure. Remove contaminated clothing. Move person to fresh air. Environmental precautions:

Do not discharge into the subsoil/soil. Do not discharge into drains/surface waters/groundwater. Contain contaminated water/firefighting water. A spill of or in excess of the reportable quantity requires notification to state, local and national emergency authorities. This product is not regulated by CERCLA ('Superfund').

Cleanup:

Dike spillage. Sweep/shovel up. Avoid raising dust. Use wet cleaning methods when applicable. Place into suitable containers for reuse or disposal in a licensed facility. Spilled substance/product should be recovered and applied according to label rates whenever possible. If application of spilled substance/product is not possible, then spills should be contained, solidified, and placed in suitable containers for disposal. 7. Handling and Storage

Handling

Respiratory protection:
