Reapply only as necessary; **As a wettable powder**, Apply in sufficient water to obtain maximum coverage. Dilution of the material should be at the rate of one half pound in one half gallon of water or at a maximum of one pound to 25 gallons of water. **To apply** Diatect III into cracks and crevices, use a bulbous duster or other suitable equipment. Apply lightly and uniformly in treatment area. The amount to be applied will vary with the site, but should usually be 8 to 16 oz. Per 1,000 sq. ft. Repeat treatment as necessary to maintain adequate control.

#### Apply either as a Dust or as a Wettable Powder.

Water Method use 2 ounces (1/4 cup) to one gallon of water. It is best to keep the material agitated during application.

To control insects such as but not limited to, Ants, Armyworms, Caterpillars, Chinch Bugs, Cutworms, Fire Ants, Fleas, Lice, Ticks, Cockroaches, Silverfish, Spiders, Box elder Bugs, Crickets, Sow bugs, Pill bugs, Ground Beetles, Earwigs, Millipedes, Centipedes and Scorpions.

**Fire Ants:** <u>As a Dust:</u> For best results; dust the perimeter of the mound first. With a stick, disturb the mound, then dust mound in a circular motion working toward the center until the mound is thoroughly dusted. <u>Mound Drench</u> or <u>Water Method</u>: Use 2 ounces (1/4 cup) to one gallon of water. For best results, saturate the perimeter of the mound first, working toward the center of the mound in a circular motion (you may want the mixture to puddle). An ant mound 12-14 inches in diameter requires approximately one gallon of mix.

Ants, Cinch Bugs, Caterpillars, Cut Worms, Armyworms, Fleas and Ticks <u>As a Dust</u>: The best results are obtained when applied with a hand or power duster or other suitable means of application to the infested area. Apply lightly and uniformly to the treatment area. <u>Hand Sprayer</u>: Use 2.0 oz. (1/4 cup) to one gallon of water. It is best to keep the material agitated during application. Apply the contents to pre-measured area.
